This **MEMORANDUM OF UNDERSTANDING** is entered at Chennai on this 19th day of December 2024.

And

Department of Botany, Queen Mary's College (Autonomous), Chennai 600004

An Autonomous College affiliated to University of Madras and Re-Accredited with "A" Grade by NAAC, established under 12B & 2F of UGC which is serving over 55 glorious years for the society, represented by its **PRINCIPAL** (which expression shall include its representatives, successors and assignees), hereinafter called the **PARTY OF THE SECOND PART**.

Following the successful co-operation between the two institutions hereby confirm their wish to the Memorandum of Understanding on education, training, workshops, internship, skill development programs and research collaborations.

WHEREAS,

NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSETH AS FOLLOWS:-

1. To undertake **joint research projects and joint publications** of scientific papers and educational materials resulting from the collaboration
2. To **implement internships / summer projects / project work / practical learning etc.**
3. To organize and co-hosting of lectures, meetings, **Seminars / Conferences / Symposia / FDPs (Faculty Development Programs) / Trainings**, etc. on subjects / domains of mutual interest for the faculty, students & academic fraternity

The terms of cooperation for each specific activity implemented under this Agreement of Cooperation shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of that activity. Any such agreements entered into, as outlined above, will form appendices to this Agreement of Cooperation. Each institution shall designate a liaison officer to develop and coordinate this specific activity agreed upon.

This agreement becomes effective on the date of signature. It is valid for five (5) years with the understanding that either party may terminate the Agreement with six (6) months' notice in writing, unless an earlier termination is mutually agreed upon. Revisions or modifications may be proposed at any time, effective from the date of written agreement signed by both parties.
