This Memorandum of Understanding (MoU) between Queen Mary's College (A), Chennai 600004 and Sacca Institute of Freight and Tourism, Chennai Sets forth the agreement of the parties with respect to mutually benefit initiative to strength the training system and facilitate knowledge partnership for Academic and Training Programmes for Students.

1. Objective and Role of Partnership

- 1.1 Queen Mary's College (A), Chennai 600004 and Sacca Institute of Freight and Tourism, Chennai, partnership is constituted in mutual consultation with each other and based on the overwhelming positive response for academic and Training collaboration for mutual benefit of both the partnership concerned.

- III. Workshop for Students
- IV. Placement for eligible students

1.4 Internship Training Program during Summer:

All students of M.Sc GTA of Queen Mary's College will be sent to the Sacca Institute of Freight and Tourism, Chennai during the summer vacation falling between the 2nd & 3rd Semester for Industrial training. During the training each student will be provided with:

- Training in various aspects to develop as an Employee
- Guidance & Maintain the Business in Tourism and Cargo Industry.
- Guidance to Self-Help/Women Entrepreneurship in Tourism and Cargo Industry.
- Guidance to Become a Sociopreneur Women



1.5 The primary objective of the partnership is to provide a platform to facilitate Knowledge Sharing.

Hence the methods of functioning will be as follows:-

- (i) Help the process for Faculty Development in both organizations by taking up Joint Research and Consultancy Projects
- (ii) Jointly Identify Expert Resource Persons

2. Member of the Partnership Committee

2.1 The partnership committee will comprise Principal, Queen Mary's College(A), Chennai - 4 and Head, Department of M.Sc GTA(Geography, Tourism and Administration), Queen Mary's College (A), Chennai 4 and representatives of the Sacca Institute of Freight and Tourism with a term of One year with subsequent renewals and modifications for a further period of one year, subject to renewal of this MoU.

- 2.2 The partnership committee would meet once every year to take stock of the progress and give directions to the various clauses for implementation.
- Queen Mary's College (A), Chennai 4 and Sacca Institute of Freight and Tourism would provide dedicated staff to work very closely to achieve the goals of the partnership. The members of Sacca Institute of Freight and Tourism and Department of MSc GTA, (Geography, Tourism and Administration) Queen Mary's College (A), Chennai will be the coordinators for the partnership committee.
- 2.4 The Agreement shall commence on 12.10.2021 and shall continue in force until terminated by mutual consent after prior written notice by either party to the other party. The termination will be subject to compliance to the completion of all commitments made. Notwithstanding any such termination, both parties shall ensure that all activities in progress are completed successfully.
- 2.5 This MoU will be valid for a period of one year from the date of signing of this MoU. After the expiry of this period, the MoU may be extended for further three years based on mutual Interest.

MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING ('MOU') is executed at Chennai on this 09th day of July 2014

BY AND BETWEEN

AIRPRO™ ACADEMY (A division of AIRPRO GLOBAL CORP PVT. LTD.) (herein after referred to as "AIRPRO") having its registered office at 28/27, 2nd Floor, Damodharan Street, T Nagar, Chennai – 600017

AND

QUEEN MARY'S COLLEGE (herein after referred to as "QMC") at Kamaraja Salai, Opp. IG Office, Mylapore, Chennai - 600004.

WHEREAS

QMC has chosen AIRPRO, to be its training partner for Certificate Course in Air Fare & Ticketing.

WHEREAS

AIRPRO agrees to work with QMC, for providing Certificate Course in Air Fare & Ticketing to the students of QMC.

NOW THEREFORE THIS MOU WITNESSETH AS UNDER:

- 1. That this MOU would be valid for the tenure of 20 working days with effect from the date 9th July 2014. This term may be extended on mutual consent.
- 2. That the Certificate Course in Air Fare & Ticketing training program would be conducted by AIRPRO as per contents mutually agreed upon and thereafter, the evaluation and certification will be carried out by AIRPRO at college premises.

- 3. That AIRPRO would invoice QMC at the rate of INR 500/- per student, as the total number of students declared by QMC are 60 No.s for the above mentioned agreement period. This would include the cost of training, certification, included test and evaluation. The rate of fee would be reviewed for the second year.
- 4. Since AIRPRO has to incur necessary expenditure to conduct the training program, trainee must pay 25% of the fees during the day of the course commencement and 25% should be paid 10 days after the class begins and rest of the amount during the last day of course completion.
- 5. That training aid, viz. other basic requirement for the training such as board, and related infrastructure like furniture, fixtures, electricity etc. would be provided by QMC
- 6. That QMC representative has the right to oversee at any time, the training program conducted by AIRPRO
- 7. That either party may terminate this MOU by serving not less than 30 days' written notice to the other party. The parties shall continue to perform their respective obligations during the notice period.
- 8. Total class hours will be 40 hours i.e. 2 hours per day from Monday through Friday, which is divided into 30 hours of class room training and 10 hours of project work.
- Evaluation will be done by AIRPRO. Final examination marks will be for 100 out of which 50 for written exam, 25 for project and remaining 25 for viva voce.

- 10. That the student should score a minimum qualifying grade of 40% in the evaluation in order to be awarded with the certificate.
- 11. Examination will be conducted in the QMC premises.

This MOU shall be governed by and construed in accordance with the Laws of India, and the parties submit to the exclusive jurisdiction of the courts of Chennai in respect of any dispute or difference between them arising out of this MOU.
